## ANNOUNCEMENT OF OFFER PRICE AND PRELIMINARY ALLOTMENT RESULTS

## **SUMMARY**

- This announcement sets out, among other things, (a) the update on Global Offering in relation to the expected issue of Supplemental Prospectus containing revised timetable for the Global Offering, (b) determination of the Offer Price, (c) the level of valid applications and preliminary allocations in the Hong Kong Public Offering and the CNT Preferential Offer, subject to such applications being validly confirmed by the Eligible Hong Kong Applicants and Eligible CNT Applicants, (d) confirmations on valid applications, (e) refund arrangement in respect of partially unsuccessful applications, and (f) the International Offering.

### **Update on Global Offering in relation to the expected issue of the Supplemental Prospectus containing revised timetable for the Global Offering**

- Reference is made to the Company's announcement dated 29 June 2017 (the "**Announcement**"), a petition (the "**Petition**") was filed by the Chinaculture.com Limited, a substantial shareholder of CNT, on 22 June 2017 in respect of the Spin-off and the Listing on the ground the Spin-off and the Listing are being conducted in a manner oppressive and unfairly prejudicial to the interests of the shareholders of CNT, including the Petitioner. In order to allow investors of the Offer Shares to have more time to consider the potential impact of the Petition, the Company will issue the Supplemental Prospectus, which is expected to be issued by the Company on Friday, 30 June 2017.
- The Supplemental Prospectus will include, among others, the consequential effect of the Petition, amendments to the Prospectus and a revised expected timetable for the Global Offering. Dealing in the Shares on the Main Board of the Stock Exchange is expected to commence on Monday, 10 July 2017. Further, in order to enable Eligible Applicants to consider the potential impact of the Petition on their investment decision, the Company and the Joint Global Coordinators would like the Eligible Applicants to refer to the Supplemental Prospectus which is expected to be issued by the Company on Friday, 30 June 2017 for details of these matters.

### **Determination of the Offer Price**

- The Offer Price has been determined at HK\$0.86 per Offer Share (excluding brokerage fee of 1.0%, SFC transaction levy of 0.0027% and the Stock Exchange trading fee of 0.005%).

**The level of valid applications and preliminary allocations in the Hong Kong Public Offering and the CNT Preferential Offer, subject to such applications being validly confirmed by the Eligible Hong Kong Applicants and Eligible CNT Applicants**

- The Hong Kong Offer Shares initially offered under the Hong Kong Public Offering have been very significantly over-subscribed. A total of 9,784 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** Application Forms or **YELLOW** Application Forms and through giving electronic application instructions to HKSCC via CCASS and under the HK eIPO White Form service (www.hkeipo.hk) for a total of 3,310,192,000 Hong Kong Offer Shares, representing approximately 132.41 times of the 25,000,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering.
- The final number of Offer Shares under the Hong Kong Offer is 125,000,000 Shares, representing 50% of the Offer Shares initially available under the Global Offering (before any exercise of the Over-allotment Option).
- 37 valid applications have been received pursuant to the CNT Preferential Offer on **BLUE** Application Forms for a total of 27,605,820 CNT Reserved Shares, representing approximately 1.1 times of the 25,000,000 CNT Reserved Shares initially available for subscription under the CNT Preferential Offer. The CNT Reserved shares are not subject to re-allocation. In the event that the Over-allotment Option is exercised, the number of CNT Reserved Shares will not be changed.
- The final number of CNT Reserved Shares preliminarily allocated to the relevant Eligible CNT Applicants under the Preferential Offering is 25,000,000 CNT Reserved Shares, representing approximately 10.0% of the total number of the Offer Shares initially available under the Global Offering (assuming the Over-allotment Option is not exercised).
- Details of valid applications in the Hong Kong Public Offering and the CNT Preferential Offer, including the Final Offer Price, the level of applications in the Hong Kong Public Offering and the CNT Preferential Offer, the Hong Kong Identity Card numbers, passport numbers or Hong Kong Business Registration numbers of Eligible Applicants (where supplied) under the Hong Kong Public Offering and the Preferential Offer, the number of the Hong Kong Offer Shares validly applied for under **WHITE** and **YELLOW** Application Forms, or by giving electronic application instructions to HKSCC via CCASS or the designated HK eIPO White Form Service Provider through the designated HK eIPO White Form website (www.hkeipo.hk) and the number of CNT Reserved Shares validly applied for under **BLUE** Application Form, will be made available

in the manner specified in the paragraph headed “Applications received for the Hong Kong Offer Shares and CNT Reserved Shares” in this announcement.

### **Confirmations on valid applications**

- Eligible Hong Kong Applicants who have validly applied for Hong Kong Offer Shares and wish to confirm their applications will be required to confirm their applications only by using a **WHITE** Confirmation Form before the deadline as shall be specified in the Supplemental Prospectus. Please refer to the Supplemental Prospectus for details of where the **WHITE** Confirmation Form, which are the only means by which valid confirmations can be made, can be obtained. Eligible Hong Kong Applicants who do not confirm their applications in accordance with the procedure set out in the Supplemental Prospectus will have their applications rejected and their refund cheques are expected to be dispatched on Monday, 10 July 2017.
- Eligible CNT Applicants who have validly applied for (i) their CNT Qualifying Shareholder’s Preferential Entitlement and/or (ii) excess CNT Reserved Shares who wish to confirm their applications will be required to confirm their applications only by using a **BLUE** Confirmation Form before the deadline as shall be specified in the Supplemental Prospectus. Please refer to the Supplemental Prospectus of where the **BLUE** Confirmation Form, which is the only means by which valid confirmations can be made, can be obtained. Eligible CNT Applicants who do not confirm their application in accordance with the procedure set out in the Supplemental Prospectus will have their applications rejected and their refund cheques are expected to be dispatched on Monday, 10 July 2017. For the avoidance of doubt, Eligible CNT Applicants who have validly applied for their CNT Qualifying Shareholder’s Preferential Entitlement and/or excess CNT Reserved Shares need only confirm their applications on one **BLUE** Confirmation Form.
- Due to the very significant over-subscription in the Hong Kong Public Offer, the reallocation procedures as described in the section headed “Structure of the Global Offering — The Hong Kong Public Offering — Reallocation” in the Prospectus have been applied. As the number of Offer Shares validly applied for under the Hong Kong Public Offering is more than 100 times, a total of 100,000,000 Offer Shares initially available under the International Offering have been reallocated to the Hong Kong Public Offering and the final number of Offer Shares under the Hong Kong Public Offering has been increased to 125,000,000 Offer Shares, representing 50% of the Offer Shares initially available under the Global Offering (before any exercise of the Over-allotment Option).
- In connection with the Global Offering, the Company has granted the Over-allotment Option to the International Underwriters, exercisable by Sinolink

Securities (Hong Kong) Company Limited, as the stabilising manager (the “**Stabilising Manager**”), on behalf of the International Underwriters, at any time from the Listing Date until Sunday, 23 July 2017, being the 30th day after the last day for the lodging of applications under the Hong Kong Public Offer, to require the Company to issue and allot up to an aggregate of 37,500,000 additional new Shares, representing 15% of the Offer Shares initially available under the Global Offering, at the Offer Price to cover over-allocation in the International Offer. There has been an over-allocation of 20,000,000 Shares in the International Offering and such over-allocation is covered through the Stock Borrowing Agreement entered into between CNT Enterprises Limited and the Stabilising Manager. Such borrowed Shares will be covered by exercising the Over-allotment Option and/or by making purchases in the secondary market. In the event the Over-allotment Option is exercised, an announcement will be made. As of the date of this announcement, the Over-allotment Option has not been exercised.

#### **Refund arrangement in respect of invalid or partially unsuccessful applications**

#### **The International Offering**

## **UPDATE ON THE GLOBAL OFFERING**

## **SUPPLEMENTAL PROSPECTUS**

With reference to the Announcement, the expected timetable of the Global Offering has been revised. Dealing in the Shares on the Stock Exchange is expected to commence on Monday, 10 July 2017. Further, in order to enable applicants who have made valid applications for the Hong Kong Offer Shares ("**Eligible Hong Kong Applicants**") and Qualifying CNT Shareholders who have made valid applications for the CNT Reserved Shares ("**Eligible CNT Applicants**", together with Eligible Hong Kong Applicants, the "**Eligible Applicants**") to consider the potential impact of the Petition on their investment decision, the Company and the Joint Global Coordinators would like the Eligible Applicants to refer to the Supplemental Prospectus which is expected to be issued by the Company on Friday, 30 June 2017 for details of these matters.

The Supplemental Prospectus will include, among others, the consequential effect of the Petition, amendments to the Prospectus, and a revised expected timetable for the Global Offering. Eligible Applicants should refer to the Supplemental Prospectus for further details.

Eligible CNT Applicants who have validly applied for their CNT Qualifying Shareholder's Preferential Entitlement and/or excess CNT Reserved Shares, and whose applications have been wholly or partially successful, are required to confirm their applications that have been allocated to them on a preliminary basis on the **BLUE** Confirmation Forms. Such confirmation should be provided in accordance with the procedure set out in the Supplemental Prospectus or their applications in respect of such CNT Reserved Shares will be liable to be rejected.

Eligible CNT Applicants who do not confirm their application (for the number of CNT Reserved Shares that has been preliminarily allocated to them) in accordance with the procedure set out in the Supplemental Prospectus will have their applications in respect of such CNT Reserved Shares rejected and will be refunded their remaining application monies together with the related brokerage fee of 1%, the SFC transaction levy of 0.0027% and the Stock Exchange trading fee of 0.005%, without interest. As at the close of the application lists at 12:00 noon on Friday, 23 June 2017, a total of 9,784 valid applications (including applications which were otherwise valid by Single Board Lot Applicants) were received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms and through electronic application instructions to HKSCC via CCASS and to the designated HK eIPO White Form Service Provider through the HK eIPO White Form service ([www.hkeipo.hk](http://www.hkeipo.hk)), for a total of 3,310,192,000 Hong Kong Offer Shares, representing approximately 132.41 times of the 25,000,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering.

Due to the very significant over-subscription in the Hong Kong Public Offer, the reallocation procedures as described in the section headed “Structure of the Global Offering — The Hong Kong Public Offering — Reallocation” in the Prospectus have been applied. As the number of Offer Shares validly applied for under the Hong Kong Public Offer is more than 100 times, a total of 100,000,000 Offer Shares initially available under the International Offering have been reallocated to the Hong Kong Public Offer and the final number of Offer Shares under the Hong Kong Public Offer has been increased to 125,000,000 Offer Shares, representing 50% of the Offer Shares initially available under the Global Offering (before any exercise of the Over-allotment Option).

In connection with the Global Offering, the Company has granted the Over-allotment Option to the International Underwriters, exercisable by Sinolink Securities (Hong Kong) Company Limited, as the stabilising manager (the “**Stabilising Manager**”), on behalf of the International Underwriters, at any time from the Listing Date until Sunday, 23 July 2017, being the 30th day after the last day for the lodging of applications under the Hong Kong Public Offer, to require the Company to issue and allot up to an aggregate of 37,500,000 additional new Shares, representing 15% of the Offer Shares

initially available under the Global Offering, at the Offer Price to cover over-allocation in the International Offer. There has been an over-allocation of 20,000,000 Shares in the International Offering and such over-allocation is covered through the Stock Borrowing Agreement entered into between CNT Enterprises Limited and the Stabilising Manager. Such borrowed Shares will be covered by exercising the Over-allotment Option and/or by making purchases in the secondary market. In the event the Over-allotment Option is exercised, an announcement will be made. As of the date of this announcement, the Over-allotment Option has not been exercised.

No application has been rejected due to bounced cheque. Two suspected multiple applications have been identified and rejected. There is no invalid application which has been rejected due to completion of **WHITE** and **YELLOW** Application Forms in a manner which did not comply with the instructions set forth therein, nor any application more than 12,500,000 Offer Shares has been identified.

A total of 37 valid applications on **BLUE** Application Forms for a total of 27,605,820 CNT Reserved Shares have been received pursuant to the CNT Preferential Offer, representing approximately 1.1 times of the total number of 25,000,000 CNT Reserved Shares available for subscription under the CNT Preferential Offer.

There was no invalid application which has been rejected due to completion of the **BLUE** Application Forms in a manner which did not comply with the instructions set out therein. No multiple applications or suspected multiple applications have been identified. No applications have been rejected due to bounced cheques.

The final number of CNT Reserved Shares preliminary allocated to the relevant Eligible CNT Applicants under the CNT Preferential Offer is 25,000,000 CNT Reserved Shares, representing approximately 10.0% of the total number of the Offer Shares initially available under the Global Offering (assuming the Over-allotment Option is not exercised).
